ELECTION JUDGE TRAINING APRIL 6, 2021

10:00 A.M. – CARROLLTON WARD I, CARROLLTON WARDS II & III, CARROLLTON WARD IV, EGYPT I & II/PRAIRIE, DE WITT, HURRICANE, MOSS CREEK/WAKENDA/SUGARTREE/TROTTER, RIDGE/ROCKFORD

- Ask for Photo ID, other Identification is acceptable (there is a poster in the box showing acceptable identification)
- No identification must vote their regular ballot, but put in the blue provisional envelope. (DOES NOT GO IN THE BALLOT BOX)
- > We do not have the Yellow Provisional ballot for voters who are not in the poll pad/book. This is only for Federal elections. Contact my office if they are not in your poll pad/book.
- Post all signs
- > Take the Oath of Office, sign it and the Certificate of inspection and Payroll Sheet
- > Supervisory judges are to initial each ballot before given to the voter.
- Supervisory judges are to initial the poll book/poll pad when voter signs
- The poll book/poll pads show which ballot the voter is to receive. This should be the correct ballot. If the voter says it is not, **CALL THE OFFICE** before giving them a different ballot, so it can be researched and changed in the computer system.
- ➤ Use the "Application of Transfer of Registration" form for all address changes. The "Missouri Application for Voter Registration" cards are used for name change and new registrations only. If they register on election day, they cannot vote that day. They should have registered by March 10, 2021 to be eligible to vote this election.
- There are write-ins in the Town of Carrollton, Shoal Creek Fire District and possibly Hurricane Township. To count these, you will need both a Democrat and Republican recording tallies, and complete one precinct return with your final count. Be sure to check the write-in bins at the end of the night.
- > We have provided facial masks, hand sanitizer, both gel and liquid, face shields, posters for social distancing. These are available for your protection.
- ➤ I have purchased sneeze guards (plexiglass), two for each precinct, also for your protection.
- We are using the pens to give away again as in November. They will check in with these pens on the poll pad, and use to mark their vote. If you have trouble with the pen being dark enough, you may use the Sharpies or Flair pens.
- You will find Lysol spray cleaner (disinfects 99% of germs) and paper towels. You may also use this on the voting booth, door handles and whatever you feel is needed to be safe.
- Ambulance District-You will have lots of questions regarding voting on the Ambulance District. The Ambulance District is divided into six sub-districts across the County.

Voters can only vote in their sub-district. There are two board member seats open for this election.

- They are in Sub-District III and Sub-District VI. Sub-District III is in Combs, Eugene, Moss Creek, Sugartree, and Wakenda Townships. Sub District VI is in Carrollton Wards II and III. There are two candidates for each of these positions.
- There was a petition to recall two board members of the Ambulance District. This was certified to be enough signatures to be placed on the ballot. The board members sued the County Clerk to prohibit this from being on the ballot. The judge on Thursday ruled for the plaintiffs, but since absentee voting had been going on since February 23, it will remain on the ballot, but we are not to count these votes, report them or certify them. These are only in the Carrollton Wards. So, the voters may mark their vote and the tabulator will compile them, but they are not to be reported on election night, nor certified. So, if you do see these results on your tape, you MUST NOT TELL THESE NUMBERS to your family, neighbors, or anyone. When I compile the results at the Courthouse, the results will be hidden, so they will not be reported at all by Judges orders.
