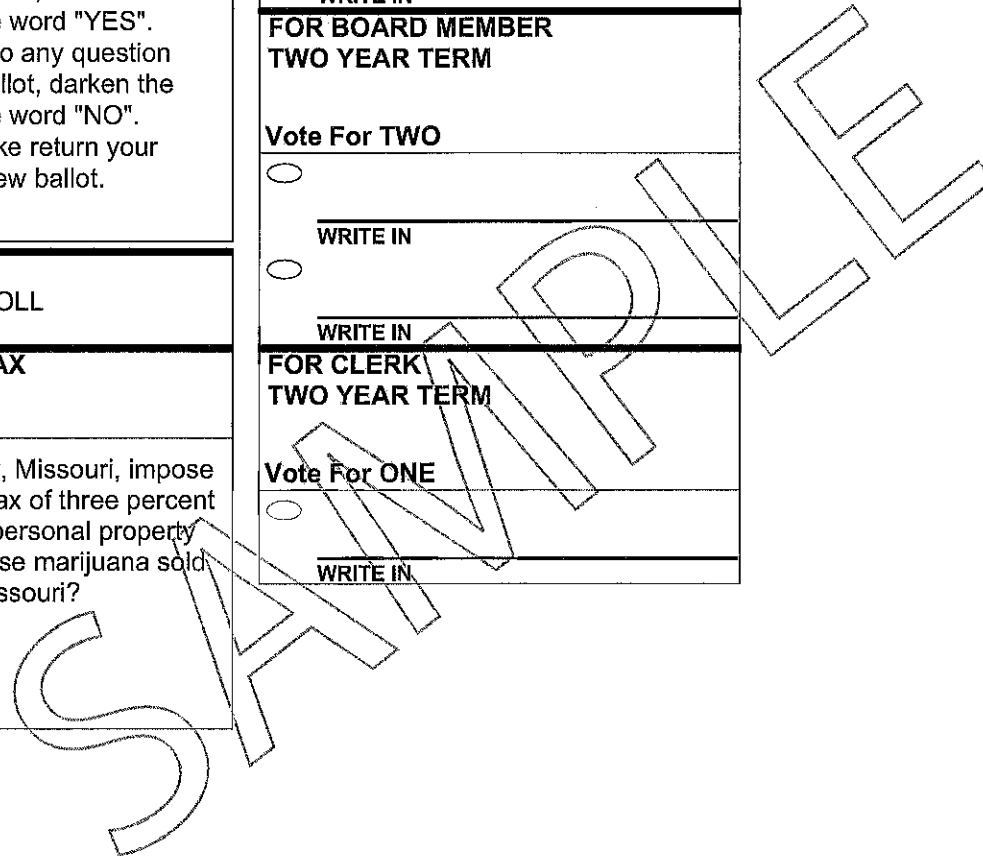

Proposition Brunswick R-II STRONG**

Shall the Board of Education of the Brunswick R-II School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Nine Hundred Thousand Dollars (\$1,900,000) for the purpose of providing funds to complete the following improvements at the Agricultural Shop and Classroom: electrical upgrades, heating, ventilation and air conditioning (HVAC) replacement, and installation of new equipment; to construct, equip, and furnish a softball concession stand to include restrooms and storage areas; to the extent funds are available, upgrade playground equipment and complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.5000 per one hundred dollars of assessed valuation of real and personal property.
