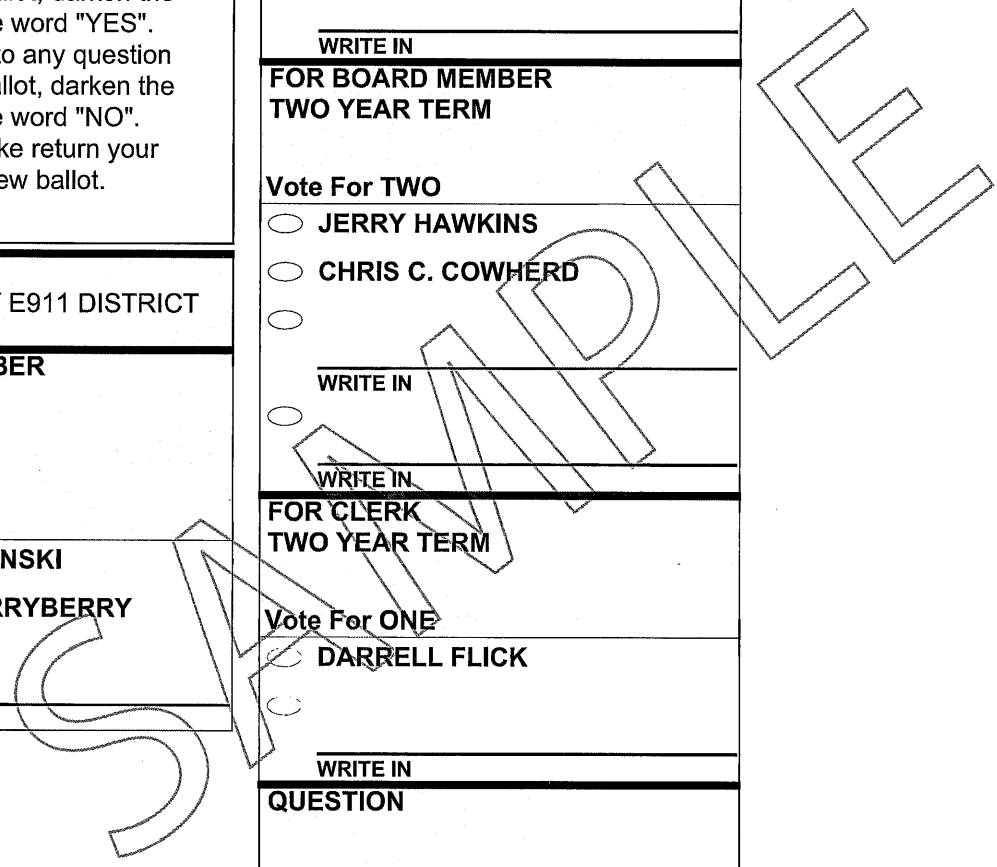

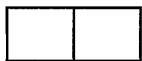

Proposition Pirates

Shall the Board of Education of the Norborne R-VIII School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million Five Hundred Thousand Dollars (\$1,500,000) for the purpose of providing funds to remodel the kitchen/cafeteria; to install a preschool playground and softball field bleachers; to complete safety improvements including, but not limited to, parking lot lighting and a new high school vestibule entrance; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.5300 per one hundred dollars of assessed valuation of real and personal property.

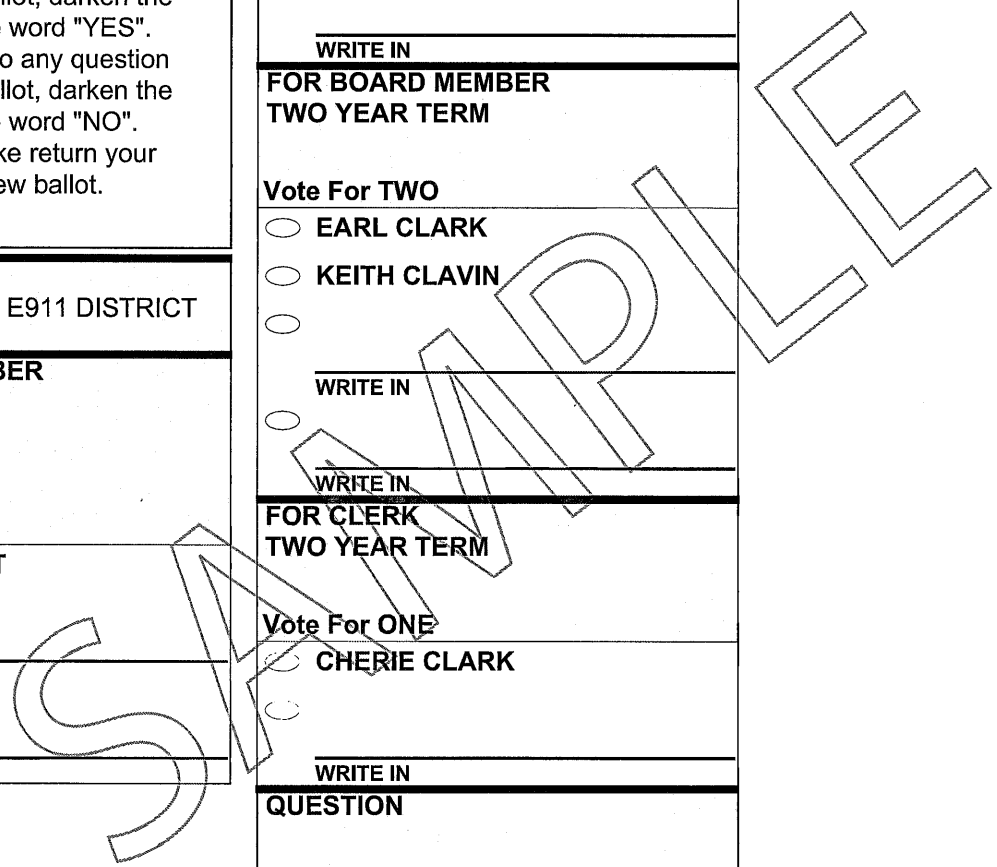
